The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant, who was identified by his New York State Driver's License, was stopped for driving w/out lights. Upon contacting the defendant I observed indicators of impairment. Defendant had watery and bloodshot eyes and there was strong odor of an alcoholic beverage emitting from his breath as he spoke with me. When asked, the defendant admitted that he'd been drinking. Defendant was administered a series of Standardized Field Sobriety Exercises (SFST's) which he was unable to perform satisfactorily. Post Miranda, defendant admitted that he felt the affects of the alcohol he'd consumed and that he shouldn't have been driving. Defendant was arrested for DUI and transported to CBT where he was administered a breath test. Defendant's BrAC measured .124 / .127 This occurred in Hillsborough County, Florida.
