ADVISORY AND SOLVENCY HEARING



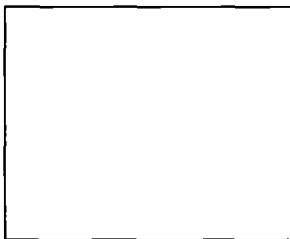
