The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 02/11/2020, at approximately 0253 hours, I was parked on the side of West Hillsborough Ave, when I observed a silver Ford Fusion, bearing Florida tag, with an assigned VIN of, to be traveling westbound on West Hillsborough Ave. Using my HCSO issued laser, I measured the speed of the Ford Fusion to be 69 MPH in a posted 50 MPH speed zone. I conducted a traffic stop on this vehicle at the intersection of West Hillsborough Ave and West Longboat Blvd. Upon contact with the defendant, who was the sole occupant, I observed him to have bloodshot glassy eyes, slurred speech and the distinct odor of an alcoholic beverage emitting from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent was read and the defendant then provided a lawful sample of his breath resulting in a BAC of .137/.134. The defendant was identified via his valid Florida driver's license.
