The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/28/2020 at approximately 2221 hours, the defendant was observed by your affiant speeding 68 mph in a posted 45 mph zone. The defendant was traveling in a red, Hyundai Elantra bearing FL tag CUY8428 (VIN:KMHD84LF9LU020922) and was the sole occupant. Upon contact with the defendant I observed bloodshot watery eyes and the strong odor of an alcoholic beverage emitting from his breath. The defendant stated he had just come from Dukes Brew House. During the completion of the SFSE's, the defendant displayed several more indicators of impairment. I transported the defendant to CBT where he refused to provide the lawfully requested breath samples, after being read implied consent in CB-01. I issued the defendant DUI citation A950LYE for DUI and a UTC AE91RTE for speeding. The defendant identified himself both verbally and by FL DL.
