The defendant was located by Cpl. White behind the wheel of his pickup truck eastbound in the inside lane of Jackson St E. The truck was stopped in the roadway with no lights activated. The truck's front drivers side tire was shredded and missing and the vehicle was sitting on the rim. The defendant had slurred speech, fumbling fingers and had the odor of an alcoholic beverage emanating from his breath. I responded to assist with a possible impaired driver. I made contact with the defendant and observed him to have slurred speech, slow movements and I detected the odor of an alcoholic beverage emanating from his breath. He agreed to participate in SFSE's which showed further indicators of impairment and he was subsequently arrested for DUI.
