On 5/12/22 at approximately 1730hrs, units were dispatched to a criminal mischief incident which had just occurred at the Advance Auto Parts located at 3600 S. Military Trl in Palm Springs, Palm Beach County, FL. The caller was updating dispatch a subject had just broken the store's front door and was running southbound on S. Military Trl. The subject was described as a W/M wearing a gray polo, shorts and sneakers. The caller and suspect were located as they were approaching the rear of Bodegon, located at 4481 Lake Worth Rd, which is just south of the Advanced Auto Parts. The caller, Andres F. Chajud, pointed at the above-mentioned suspect. I made contact with the suspect and he was detained, handcuffed behind his back, checked for tightness and double-locked. He was identified as Daniel V. Gomes 11/9/67. Andres quickly explained the suspect had entered the store asking for help and began acting aggressively and was eventually asked to leave the store. He eventually did, and they locked the door behind him. Daniel became upset, he paced the parking lot and eventually kicked the door, damaging the glass. They valued the damage at \$500. Daniel was processed on scene and eventually transported to Palm Beach County Jail.
