On 7/9/2020 at approximately 1936 hours, I responded to 5840 Town Bay Drive Apt 313 in reference to a physical domestic disturbance.

I met with Dante Giglio who advised that he and his girlfriend Danielle La Barrie got into a physical altercation. Giglio advised that they have been having relationship issues and La Barrie began going through his text messages to see if he was texting other women. Giglio stated that he went to grab his cell phone from her and she struck him in the groin with her foot. He advised that at no point did he touch La Barrie.

I then met with La Barrie who advised that she was going through Giglio's phone because she thought he was texting another woman. La Barrie admitted that she pushed Giglio in the kitchen when he reached for his cell phone. She was unsure if she kicked him in the groin but advised it was possible when in the process of pushing him.


It should be noted that both parties reside in the same household and have been in a romantic relationship for over a year.

Based on the above facts, I arrested Danielle La Barrie for domestic battery pursuant to FL State Statue 784.03(1A1). La Barrie was transported to Boca Raton PD and shortly thereafter transported to Palm Beach County Jail without incident.
