The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Danielle Moffat was driving a black Honda Pilot bearing FL(JQTJ07) that failed to negotiate the turn while getting on the on ramp to I275 from Himes Av N causing her car to ride up in the retaining wall and rolling onto it's roof. Moffat sustained minor physical injury, abrasions on her arms and leg. She refused medical treatment. The eyewitness helped Moffat out of the car. She was the sole occupant. During observations she displayed indicators of impairment to include having red glassy eyes, slurred speech and the distinct odor of an alcoholic beverage on her breath. She displayed additional indicators during SFST's and was arrested for DUI. She was taken to CBT where she was read implied consent and refused to take the breath test. Moffat verbally identified herself. Her identity was verified using DHSMV photo.
