at approximately 10:25 PM, at 75TH AVE / BLIND PASS RD, in Pinellas County did:

REASON FOR STOP: DANNY WAS TRAVELING EAST ON 75TH AVENUE TOWARDS BLIND PASS ROAD, OPERATING HIS BROWN 2012 BUICK (KY TAG 5072FR). DANNY STRUCK A TOYOTA 4RUNNER WHILE ATTEMPTING TO TRANSITION INTO THE TURNING LANE TO HEAD NORTH ON BLIND PASS RD. 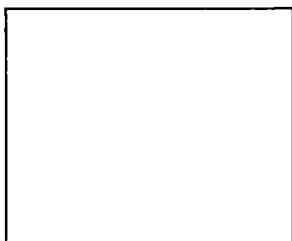
