The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 07/28/2020, at approximately 2111 hours, Deputy S. Ross (ABN 129331), responded to the intersection of East Bearss Ave and Bruce B Downs Blvd, in reference to a traffic crash involving a black Hyundai Sonata (FL tag: HCTC06, VIN: 5NPEB4AC8EH833264) and a green Toyota 4Runner (FL tag: ECUR65, VIN: JT3HN87R5X0234835). The defendant was operating the Toyota 4Runner when she struck the rear of the Hyundai Sonata with the front of the Toyota 4Runner. As a result, the vehicles sustained approximately \$4,500.00 in total damages. Upon arrival, I observed the defendant to be sitting in the driver's seat of the Toyota 4Runner. Upon contact with the defendant, she had bloodshot glassy eyes, unsteady balance and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI with property damage. Implied consent was read and the defendant refused to provide a lawful sample of her breath. The defendant was identified via her Florida driver's license.
