PROMISE	<p>On Saturday, July 24, 2021 at 1718 hours, I was dispatched to Taverna Kyma restaurant located at 6298 N Federal Hwy in the City of Boca Raton in reference to the report of a road rage incident. Upon my arrival, I met with Darren Mc Morrow (10/11/1963) who advised of the following which is a summary and not verbatim:</p>								
	<p>Darren stated that the incident began at the intersection of N Federal Hwy and E Yamato Rd. Darren stated that she was driving his motorcycle turning northbound on N Federal Hwy. As he was turning, Darren stated that his motorcycle had trouble shifting gears which caused him to slightly exit his lane near the vehicle next to him. Darren stated that the vehicle then sped past him aggressively then drove parallel to him as he was riding north on N Federal Hwy. Darren stated that the driver, later identified as Victim #1, was accompanied by a female. While both vehicles were traveling northbound, Darren stated that Victim #1's vehicle, a silver 2021 Honda Passport, attempted to run him off the road. Darren stated that he was not struck by the vehicle at any point and followed it to the front parking lot of Taverna Kyma where he proceeded through and parked in the rear parking lot. Once in the rear parking lot, Darren stated that he approached Victim #1 to confront him about the incident. Darren stated that Victim #1 called him several names and at one point, they were arguing face to face approximately one (1) foot apart. According to Darren, the incident was verbal only and not physical at any point. Darren stated hat during the argument, Victim #1 spit in Darren's face while yelling, however, there were no signs of saliva on Darren's face, clothing, or motorcycle helmet. Additionally, Darren had no visible injuries.</p> <p>I then observed two (2) employee's of Taverna Kyma who appeared to want to speak with me about the incident, Gustavo Dos Santos (08/18/1994) and Kevin Papa (02/26/2003). I interview both separately where they advised of the following in a sworn recorded statement:</p>

Gustavo stated that he was working near the patio area of the restaurant when he heard loud arguing coming from the rear parking lot. Gustavo stated that he observed Darren and Victim #1 arguing with one another, describing Darren as the primary aggressor. While Darren and Victim #1 were standing near the rear of Victim #1's vehicle, Gustavo observed Darren swing his arm at Victim #1's head, striking him in the face with his fingers. After Darren swung at Victim #1, both separated and awaited the arrival of BRPD.

Kevin stated that he was working inside of the restaurant when he heard yelling from the rear parking lot area. Kevin stated that he heard the argument and Darren was yelling at Victim #1 about cutting him off. Kevin stated that Darren and Victim #1 were standing very closely to one another and Darren was attempting to get Victim #1 to fight him. Kevin stated that he witnessed Darren, using his right hand, swing toward Victim #1's head and strike him in the face area. Afterwards, Darren and Victim #1 separated and waited for BRPD.

I then spoke with Victim #1 in the rear parking lot area. Victim #1 stated that the incident began in the intersection of N Federal Hwy and E Yamato Rd as he was turning northbound. Victim #1 stated that Darren began following him while driving his motorcycle in the bicycle lane in the blind spot of his vehicle. Victim #1 stated that he was driving to Taverna Kyma for dinner and he pulled into the parking lot which was full. Darren continued to follow Victim #1 through the parking lot and into the rear parking lot area where Darren confronted him. Victim #1 stated that he exited his vehicle and Darren approached him aggressively. Victim #1 stated that he was attempting to avoid the situation and that he and Darren were standing closely when Darren swung at his head which struck his face. I did not observe any visible injury to Victim #1's face. Victim #1 stated that after he was struck by Darren, they separated and waited for BRPD. Victim #1 stated that his wife, was present during the incident. It should be noted that at the time of this incident, Victim #1 was 70 years of age and wished to pursue criminal charges against Darren.

I then spoke with Polly in the rear of the restaurant. Polly stated that Darren began following them while driving north on N Federal Hwy while in the bicycle lane. Polly stated that Darren followed them to the rear parking lot of Taverna Kyma. While in the parking lot, Victim #1 exited the vehicle and was approached by Darren. Polly stated that she witnessed Victim #1 and Darren arguing but it not witness any physical contact because she remained inside of the vehicle. Polly had no further information to add.

I then met with the Taverna Kyma management in reference to possible video footage of the incident. The on-duty manager stated that the restaurant does have cameras that face the direction of the area in which the incident occurred, but were unable to be accessed at the time of this investigation. I instructed her to contact BRPD when the cameras could be accessed.

This investigation determined that Darren did actually and intentional touched the victim, Victim #1, against his will with the intention to cause bodily harm where Edward was at the time 65 years of age or older.</p> <p>I then informed Darren that he was under arrest and he was placed in handcuffs without incident. I then transported Darren to BRPD for arrest processing. While at BRPD, Darren complained of unrelated health issues and was transported to Boca Regional Hospital for evaluation. Once cleared from Boca Regional Hospital, I transported Darren to the Palm Beach County Jail.</p>
