The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 I Officer Malachi Wilkins of the Florida Fish and Wildlife Conservation Commission was on state water patrol in Hillsborough County, Florida. At 1948 hours I arrived on scene of Hillsborough Bay just off MacDill Air Force Base in regards to a call for service for that the MacDill Air Force Base Security Forces called in. The call I received was about a boat that was inside the MacDill Air Force Base security zone and the operator of that boat was possibly impaired. A1C Mark Canino with the Air Force Marine Unit identified the defendant as the operator and stated that he observed signs of impairment during his encounter with the defendant. When I arrived on scene I smelled the strong odor of an alcoholic beverage coming from his breath as I spoke to him. I also observed his eyes to be glossy and bloodshot. I asked the defendant if he would consent to performing seated field sobriety tasks and he said that he was willing to do so. The defendant performed poorly on them and was placed under arrest and was read Implied Consent and he said that he did not want to provide a sample of his breath.
