The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above date and time, at the above location, the DEF was operating a motor vehicle while unlawfully impaired. I responded as a backup officer to a traffic stop (See Ofc. Osborn 604E Supplement) which was conducted on the DEF, due to the driving with the registration on his vehicle being expired (witness by OFC. Osborn). Upon arriving at the above location, I made contact with the DEF and I immediately could smell a strong odor of an alcoholic beverage coming from the DEF exhaled breath. The DEF also had slurred speech and was slow to respond to questions. The DEF had glassy and bloodshot eyes. The driver also spontaneously stated that he had "three beers" about an hour before the traffic stop. I asked if the DEF would perform standardized field sobriety exercises. The DEF Stated that he, "wanted to go home" and "no". When the DEF exited the vehicle, he started to sway from side to side and showed difficulty walking in a straight line. The DEF was read implied consent on scene, which he refused by stating "no". Due to my observations and interaction with the DEF, I believed he was operating a motor vehicle while being impaired beyond the legal limit and was arrested. I then, conducted an inventory search of the DEF's vehicle, prior to it being impounded, and located a freshly open Yuengling can, which was cold and located in the back-passenger side floorboard, which was within reach of the DEF.
