ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE CHERYL ANN FECHT, HIS WIFE, WHO IS NOT LIVING WITH HIM AND HAS MOVED BACK TO HER CONDO, AGAINST THE WILL OF CHERYL ANN FECHT, TO WIT: BY GRABBING THE VICTIM BY THE THROAT CAUSING A SMALL SCRATCH ON HER LOWER RIGHT JAW.

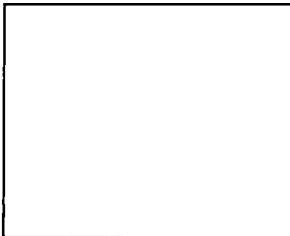
