On the 2 day of March, 2020 at 00:36 (Specifically include facts constituting cause for arrest.)

On 03/01/2020, at 2350hrs, I responded to the area of Military Trl./University Blvd. in reference to a subject (W/M, blue shirt, khaki shorts) pulling on the door handle to 500 University Blvd, Suite 106. Upon arrival, I canvassed the area and located a white male (wearing a blue shirt and khaki shorts) pulling on the hinge of Suite 109 (north exterior door of 500 University Blvd., facing University Blvd.). I subsequently parked my marked patrol vehicle along University Blvd., and illuminated the white male with my patrol vehicles Alley Light. As I exited my marked patrol vehicle, the white male attempted to conceal himself behind two pillars, nearest Suite 109. The pillars are spaced in such a way that I was able to maintain a visual of the male and call him out toward the open walkway. The male, who appeared intoxicated (unsteady on his feet, slow and deliberate movements, required multiple commands to effect a proper response) complied and stood in the open area.

Upon the arrival of a backup officer, Ofc. Hobby, I proceeded to make contact with the male (later positively identified to be David Murray W/M 03/10/84). I asked the Murray to face the wall and told him I was going to conduct a cursory pat down for weapons, as the behavior observed upon contact (i.e. pulling on hinge, initial concealment, and multiple commands to keep his hands out of his pockets) gave me immediate concerns for officer safety. As I was conducting the cursory pat down, Murray gave me verbal consent to retrieve items from his left front pocket. Murray advised his phone was in said pocket, but upon searching the pocket two phones were found. A newer iPhone (possibly iPhone 11 Max) was verified to belong to Murray. The second iPhone (in a case with cracked screen) was located and multiple missed phone calls from 561-376-0985 were observed on the front screen. I subsequently called the phone number, spoke with a female, was told the phone was lost at Jumby Bay and did not belong to Murray.

At this time, I read Murray his Miranda Warnings, to which he verbal confirmed he understood. I asked Murray where he obtained the second iPhone, to which he was unable

to understand due to his level of intoxication. The inability to answer and respond to simple questions continued throughout the ensuing conversations, and ultimately provided no information as to how he obtained the second cellphone.

Due to Murray's level of intoxication he was unable to gain access to his cellphone (did not remember the passcode), believed he was currently in Palm Beach Gardens attempting to gain access to a friend's residence, clothes were disheveled (zipper down and belt falling off), and could not provide his own home address until read to him from his Driver's License. These factors, along with his actions prior to my arrival (pulling on a closed business' door handles), as well as attempting to hide from Law Enforcement, gave me great concern for the endangering of his safety and the safety of the motoring public (note: our location was at the corner of Military Trl, which consistently sees traffic throughout the night).

As a result of my investigation, including the actions of Murray, probable cause exists to charge David Murray contrary to Florida Statute 856.011(1) as he was intoxicated and endangered the safety of another person or property, or was intoxicated or drank an alcoholic beverage in a public place or in or upon a public conveyance and caused a public disturbance.
