The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 22 day of APRIL, 2020,

at approximately 11:15 PM, at 38500 US HIGHWAY 19 N, in Pinellas County did:

UNLAWFULLY HAVE IN (SELECT: HIS/HER) ACTUAL OR CONSTRUCTIVE POSSESSION, A SUBSTANCE DEFINED BY FLORIDA STATE STATUTE CHAPTER 893, TO WIT: BUPRENORPHINE & NALOXONE, WITHOUT HAVING LAWFULLY OBTAINING SAID SUBSTANCE FROM A VALID PRACTITIONER. THE SUBSTANCE WEIGHED APPROXIMATELY 0.1 GRAMS. THE BUPRENORPHINE & NALOXONE WAS IDENTIFIED THROUGH DRUG.COM AND RX LABEL.

THE DEFENDANT, DAVID D. KLOCKOWSKI, TO WIT, WAS FOUND IN POSSESSION OF (5) BUPRENORPHINE AND NALOXONE SUBLINGUAL FILM 8MG AND (3) BUPRENORPHINE HYDROCHLORIDE 8 MG PILLS.

A CONSENSUAL ENCOUNTER WAS CONDUCTED WITH THE DEFENDANT, AS HE WAS OBSERVED PARTIALLY PARK ON A CURB IN THE ST. PETERSBURG COLLEGE PARKING LOT. THE DEFENDANT STATED HE WAS TIRED AND DID NOT REALIZE HE WAS PARK ON A CURB.

THE DEFENDANT CONSENTED TO STEP OUT OF HIS VEHICLE UPON BEING ASKED. PINELLAS COUNTY DEPUTY J. FINERAN OBSERVED IN PLAIN VIEW A CUT PORTION OF A BLUE IN COLOR PLASTIC GLOVE WITH AN UNKNOWN SUBSTANCE ON THE DRIVER SEAT WHERE THE DEFENDANT HAD BEEN SITTING.

BASED ON TRAINING AND EXPERIENCE IT WAS BELIEVED THE PLASTIC GLOVE CONTAINING AN UNKNOWN ILLEGAL CONTRABAND. THE PLASTIC GLOVE REVEAL THREE WHITE ROUND PILLS WITH THE IMPRINT OF 8 AND AN ARROW. THE PILL WAS IDENTIFIED AS BUPRENORPHINE HYDROCHLORIDE 8 MG A SCHEDULE THREE NARCOTIC, VIA DRUGS.COM

BASED ON THE DISCOVERY OF THE NARCOTICS THE DEFENDANT WAS TAKEN INTO CUSTODY. SEARCH INCIDENT TO ARREST, THE DEFENDANT'S WALLET WAS LOCATED ON HIS PERSON. DURING A SEARCH OF HIS WALLET (5) BUPRENORPHINE AND NALOXONE SUBLINGUAL FILM 8MG WERE LOCATED INSIDE.

POST MIRANDA THE DEFENDANT STATED HE WAS PRESCRIBED THE BUPRENORPHINE A LONG TIME AGO. THE DEFENDANT WAS UNABLE PROVIDE HIS PRESCRIPTION FOR THE NARCOTIC, AS WELL PROVIDE A REASON WHY THE PILLS WERE LOCATED IN A CUT PLASTIC GLOVE.

CONTACT WAS MADE WITH THE DEFENDANT'S MOTHER WHO HE CURRENTLY RESIDES WITH. THE DEFENDANT'S MOTHER WAS UNABLE TO PROVIDE A PRESCRIPTION FOR BUPRENORPHINE FOR THE DEFENDANT.

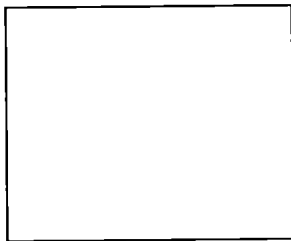
