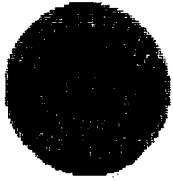

While on patrol in Palm Beach County, while running rear stationary radar on northbound Interstate-95 ( State Road 9 ) at 45th Street, I observed a pickup truck traveling north on Interstate-95 at a very high rate of speed. I visually estimated the vehicle at a rate of speed of 100 to 105 miles per hour in a 65 miles per hour zone. My Stalker Dual rear radar, serial number DC 090630 had a very high tone and its counting unit it showed the pickup, the only vehicle in the area, with a speed of 107 miles per hour in a 65 miles per hour zone.

I then placed my fully marked patrol in forward gear and started forward in an attempt to over take the vehicle with the attempt of a traffic stop on the gray GMC Sierra pickup ( FL tag " HHQV46 " ). I activated my patrol vehicle emergency blue lights and the gray pickup slowed down, and stopped on the right paved shoulder of northbound Interstate-95 just before the exit for State Road 708 ( Blue Heron Blvd ). I exited my patrol vehicle and walked up the driver side window and first met with its male driver later identified as Mr David Edward Wilensky ( FL DL # W-452-165-94-229-0 ). I advised why I stopped the reason why I stopped his vehicle. While I was talking to Mr. Wilensky, while still in his vehicle, I observed that Mr. Wilensky had bloodshot watery eyes and slurred speech. A short time later I had Mr. Wilensky exit his vehicle and walk back to the front of my patrol unit. As Mr. Wilensky was walking back towards my vehicle, I observed a water stain on the front of his tan in color shorts.

When he exited his vehicle and I came face to face with him, I observed that Mr. Wilensky emitted a strong odor of alcohol from his breath and person. I asked him where he was going where he stated that he was going home to the Jupiter, FL area. I then asked where he was coming from he stated that he was coming from a birthday party that was at restaurant called " Greece " in the downtown area of West Palm Beach, FL. I asked Mr. Wilensky if he had consumed any alcoholic drinks, he stated that he only had one drink around 930pm-10pm. During the questioning, he slightly swayed.

Based on my observations, I asked Mr. Wilensky if he would submit to roadside sobriety exercises. At first he stated he might have to speak to a lawyer, but I advised him that he did not have a right to a lawyer at the time. Moments later Mr. Wilensky stated that he would submit to the exercises. I asked if he wore glasses, he stated that he does not wear glasses. I asked if he had any medical

issues. Mr. Wilensky stated that he has had medical issues with his left knee.

The first exercise was "HGN". Mr. Wilensky had lack of smooth pursuit, rapid pupil movement( nystagmus ) on both left and right eyes, and prior to forty five degrees. During the exercise Mr. Wilensky slightly swayed.

The next exercise was the "Walk And Turn". I layered down a long piece of grey in color duct tape on the right paved shoulder. I then instructed the exercise for Mr. Wilensky. On the first nine steps Mr. Wilensky stepped on the line on the fourth step, did not keep heel to toe on step 7, 8, and 9, and slightly raised his arms. On the return nine steps, he did not keep heel to toe, swayed, and held his arms and hands interlocked behind his back.

The third exercise was the "One Leg Stand". Mr. Wilensky wore brown in color boat style shoes/dress shoes. During the exercise Mr. Wilensky slightly swayed, put his left foot down on count 7 one thousand, also on count 12 one thousand, and raised his arms.

Based on the evidence I placed Mr. Wilensky under arrest at 2:51 ( Dec. 11, 2021 ) for driving under the influence, and placed him in my marked patrol unit. I then transported him to the Palm Beach County breath testing center. I arrived at the breath testing center at 3:26am. After a twenty minute observation where Mr. Wilensky did not consume any food or liquid, and did not vomit, Mr. Wilensky was placed on camera in the testing center and I asked Mr. Wilensky if he would submit to a breath sample. Mr. Wilensky asked about speaking to a lawyer for an answer to the breath request. He was advised that he did have a right to a lawyer at that time. Due to Mr. Wilensky not giving an answer, I then read Florida's Implied Consent. Mr. Wilensky then stated that he would submit to the breath sample request. The breath request samples given returned with 0.173 and 0.168 g/210L.

I then finished my report and transported Mr. Wilensky to the booking center at the Palm Beach County Main Jail.

All occurred in Palm Beach County. The traffic stop, interview, arrest, and transportation to the breath testing center was recorded by my patrol vehicle's dash camera.
