On the 1 day of June 2021 at 02:54 (Specifically include facts constituting cause for arrest.)

On 06/01/2021 at approximately 0230 hours, I responded to the intersection of NE 2nd St and Dixie Hwy in reference to a white male asleep behind the wheel of a vehicle.

Upon arrival, Ofc Wright and Ofc Walker were already on scene. Ofc Wright advised that while driving around, he observed a white Toyota vehicle bearing FL tag LKAF03 stationary in the westbound lanes on NE 2nd St at the intersection with N Dixie Hwy. Ofc Wright observed this vehicle stationary at the light, which had cycled two times green, and the vehicle did not move. Ofc Wright then approached the vehicle and observed green, male David Ruditz as the driver and sole occupant of the vehicle. Ofc Wright observed Ruditz passed out with his head tilted back and mouth open. Ofc Wright then proceeded to try and wake Ruditz up by knocking on the driver side window multiple times. After multiple knocks, Ruditz woke up and became responsive. Ofc Wright observed the vehicle in Drive gear and running. Ofc Wright then told Ruditz to put his vehicle in park, turn off his vehicle, and place his keys on the dash for his safety.

Upon my arrival, I also observed Ruditz to be the driver of the vehicle. The vehicle was in the center lane to go straight (westbound) on NE 2nd St just east of N Dixie Hwy. I immediately observed Ruditz to have red bloodshot glossy eyes. Ruditz was also slurring his speech. For our safety, I asked Ruditz to step outside of his vehicle to move to the sidewalk. Once on the sidewalk, I observed Ruditz to be swaying back and forth, unable to stand still. I could also smell a strong odor of alcohol emanating from Ruditz's person. I then asked Ruditz what happened and how he ended up here at this intersection. Ruditz advised that he was coming from O'Briens and had been drinking. He further advised he had a "couple of beers" and then "some more beers" after golfing today. He advised he was trying to go home in Boca Raton, FL and he fell asleep behind the wheel.

Based on my observations of Ruditz swaying back and forth, his red bloodshot glossy eyes, and the strong odor of alcohol coming from Ruditz's breath and person, I asked



	<p>Ruditz if he would be willing to participate in field sobriety tasks to dispel my alarm that he was under the influence. Ruditz advised he did not wish to participate in the field sobriety tasks. I then advised Ruditz of his Taylor Warnings, which included reading to him verbatim from his driver's license "Operation of a motor vehicle constitutes consent to any sobriety test required by law." I also advised to Ruditz that if he declines to participate in field sobriety tasks, I will have to base my determination of whether he is under the influence on what I have observed and his statements, and his refusal to participate in the field sobriety tasks can be used against him. After advising this, I asked Ruditz one more time if he wished to participate in the field sobriety tasks. Ruditz advised he understood these warnings and still wished to decline to participate in the field sobriety tasks.</p> <p>I then placed David Ruditz under arrest for DUI. I handcuffed Ruditz and checked for double-lock and proper fit. Ofc Wright assisted with conducting a search of Ruditz's person and then placed Ruditz into my police vehicle. I then transported Ruditz to Palm Beach County Jail for a BAT. Upon arrival, I conducted a 20-minute observation and then Ruditz was taken into the BAT room. Ruditz refused to provide a breath sample. I then read Ruditz his Florida Implied Consent Warnings, and Ruditz advised he understood these warnings and again refused to provide a breath sample. I then read Ruditz his Constitutional Warnings which he advised he understood, and he agreed to answer my additional questions. See DUI Influence report. David Ruditz is being charged under F.S.S. 316.193(1a) for DUI (DUI citation issued). Ruditz's vehicle was inventoried by Ofc Wright and Ofc Walker and then later towed by Emerald towing (See Ofc Wright and Ofc Walker's supplemental reports for further details).</p>
