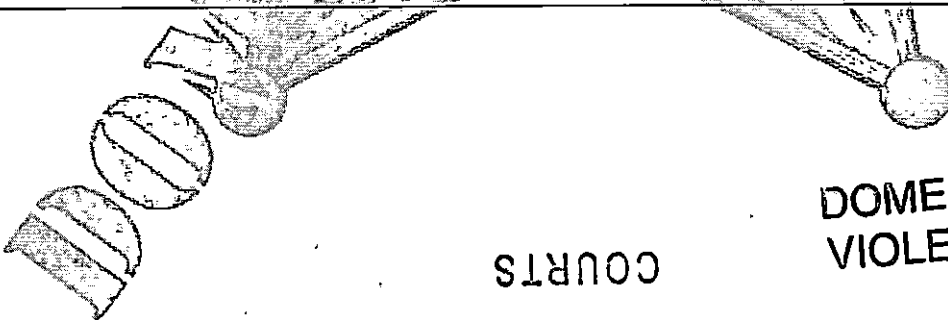

The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On April 16, 2020 at approximately 0040 hours, located at 1110 Lake Charles Cr, Lutz FL 33548 the defendant was involved in a verbal argument that turned physical when the victim started a fight with the defendant (CRA#HS20008616). The defendant and the victim then engaged in a mutual fight. The victim was in possession of a handgun which the defendant took from the victim and stuck him once on the head causing him to loose consciousness for a short period of time. The victim was struck against his will. The victim sustained a small laceration to the top of his head. The defendant is known to the victim as his step-son and is currently on misdemeanor probation under Officer Connor Felix. The defendant's identity was confirmed via DHSMV records. The victim was 74 years old.
