

At the time, I was standing outside my unmarked Jupiter Police Department patrol vehicle (vehicle 2109) and I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer.</p> <p>We had conducted a traffic stop on a white minivan with two occupants. The female occupant was arrested by Officer Lorenzo for DUI.</p> <p>I walked up to the minivan to advise the passenger, David Subers (w/m; 05/07/1962), that he needed to call a ride. When I made contact with Subers, he seemed aggravated with me and provided me with sarcastic/attitude when he answered.</p> <p>I advised Subers he could either call a ride or walk away, as we were towing the vehicle. Subers advised several times that he would walk away and never did. Subers would walk several steps south (to the front of the vehicle) then turn around and confront me again. I advised Subers multiple times to leave the area and his refusal to leave the area would result in arrest.</p> <p>Subers stated he was walking away, started calling me a "motherfucker", and never walked away. After I advised Subers more than 3 times that he needed to leave and he refused to leave the scene.</p> <p>Based on the aforementioned facts, I find Probable Cause exists to charge David Subers with Resisting/Obstructing Arrest without Violence pursuant to FSS 843.02.</p>
