I OBSERVED THE VEHICLE HAVE IT'S RIGHT TURN SIGNAL ON WHILE IN THE MIDDLE THROUGH LANE AND NEVER CHANGE LANES OR TURN AND THEN SWERVE BACK TO THE LEFT. IT WOULD AT ONE POINT STRADDLE THE LANE DIVIDER BETWEEN A TURN LANE AND THROUGH LANE, AND TRAVEL LEFT OF CENTER, ON THE WRONG SIDE OF THE ROADWAY PRIOR TO CONDUCTING A LEFT TURN WITHOUT SIGNALING. UPON MAKING CONTACT WITH THE DEFENDANT, I OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE THAT THE DEFENDANT'S EYES WERE BLOOD SHOT AND WATERY. I COULD SMELL THE ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS MOUTH THAT WOULD GROW STRONGER WHEN HE SPOKE AND HE ADMITTED TO CONSUMING ON BEER PRIOR TO DRIVING. HIS BALANCE WAS UNSTEADY AND HE WOULD SWAY OR LEAN AGAINST THE VEHICLE WHILE STANDING. 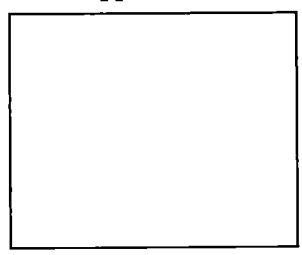
