The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a gray 2007 Toyota bearing a Florida license plate of 494RWX and was in the drive-through lane at the McDonalds. An employee, the listed witness, observed the defendant passed out/sleeping behind the wheel, and holding up the drive-through line so he called the police. Upon arrival, I observed the defendants vehicle in the drive-through lane and the defendant was in the drivers seat with the vehicle engine on and the vehicle was in drive. The defendant was passed out with his foot on the break. Upon making contact with the defendant it took several attempts to wake him up, and he failed to follow commands to put his vehicle in park. This resulted in the defendants vehicle coasting forward and striking my vehicle. The defendant exhibited multiple clues of impairment, to include; glassy and bloodshot eyes, slurred speech, unsteady stance, lethargic movements, constricted/pinpoint pupils, unable to follow simple commands, and an odor of an alcoholic beverage on his breath. The defendant was so impaired he was unable to formulate complete sentences when he was trying to answer my questions. The defendant refused to perform SFSE's and was placed under arrest for DUI. Later, he refused to provide a breath sample, despite acknowledgement of the Implied Consent Warning. In addition, the defendant has two prior refusal to submit to testing on 11/17/2011 and 01/25/2014. He has one prior DUI conviction on 06/05/2014.

The defendant was identified by his FL DL.
