The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 06/29/2020, at approximately 0147 hours, in the parking lot of the Bob Evans which is located at 102 Commercial Center Drive, Ruskin, Florida 33570 Deputy Nguyen ABN: 231827 observed the defendant in physical control of a black 2018 Ford F-150 bearing Florida tag GLGU72 with an assigned VIN of 1FTMF1CB2JKE69230 stopped in the parking lot, which was closed. Upon Deputy Nguyen's contact with the vehicle, he observed the defendant seated in the driver's seat with the vehicle running. Deputy Nguyen further observed the defendant have several indicators of impairment. Deputy Nguyen located the vehicle while on routine patrol of his zone. Upon the affiant's contact with the defendant, I observed him to have blood shot watery/glassy eyes, slurred speech, a red in color face, he was slightly unsteady on his feet, and I smelled the faint odor of an alcoholic beverage emitting from his breath. The defendant elected to participate in field sobriety exercise and while doing so, he demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration, he was arrested for DUI. The defendant was transported to Central Breath Testing and he provided two lawful breath samples of .165 and .160 . The defendant was convicted Guilty of DUI on 07/22/2008. The defendant identified himself verbally. I further identified the defendant via his DAVID photograph.
