The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 09/26/2020, I responded to 11210 41 Hw S. Gibsonton, FL. 33534 to assist Deputy Route(ABN:210966) with a traffic crash(89439047). I observed a white in color, Toyota Tacoma(KXPP58/5TFRX5GN9LX171570) to have struck a tree. The approximate dollar amount of damage due to the traffic crash was, \$1500.00 for property damage and \$4500.00 for the vehicle damage. The witness was able to identify the defendant as the driver. When I made contact with the defendant, I observed him to have poor balance, slurred speech, watery/glassy eyes, odor of an alcoholic beverage emitting from his breath, and fumbling fingers. The defendant elected to perform the standardized field sobriety exercises, but due to the safety of the defendant the standardized field sobriety exercises were concluded. Post-Miranda, the defendant stated he did not drink anything. At Central Breath Testing, at Orient Road Jail, the defendant elected to provide lawful breath samples. The breath samples were recorded at .202 and .195. the defendant has two prior driving under the influence convictions from 03/31/2001 and 06/30/2008. The defendant was identified via Florida driver's license.
