The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above date and time, the victim and defendant engaged in a verbal altercation outside of the residence. The victim stated during this altercation the defendant spit in her face then pushed her to the ground. The victim advised she went into the residence with the defendant following. Once inside the residence, the victim advised the defendant grabbed her around the neck and pushed her up against the stove in the kitchen. I did not observe any injuries to the victim. Post Miranda, the defendant advised he never spit on or punched the victim. The defendant stated he pushed the victim because she punched him first. The defendant advised he never put his hands on the victim's neck and never pushed her up against the stove inside of the residence. The victim and defendant are currently in an intimate relationship, reside as a family unit, and have a child in common. Two witness' stated they observed the defend strike the victim and push the victim down outside of the residence. Neither witness observed any actions within the residence. The victim identified the defendant as the individual who committed this offense. I identified the defendant utilizing a database photograph.
