Upon arrival, contact was made with the complainant/victim who was crying and was later identified as Karen Lazer Strugis (Victim). Mrs. Lazer Strugis advised the following: On today's date, she checked her husband of less than one year, David Lazer Strugis (Defendant) phone and found out he was cheating on her with another woman. She confronted the defendant and he became angry and struck her on her right arm and kicked her multiple times on her legs and buttocks. The defendant then grabbed all of the victim's belongings and threw them out of the apartment. The victim then proceeded to 9-1-1. While speaking to Mrs. Lazer Strugis I observed a black bruise on her right arm consistent with her statement. Mrs. Lazer Strugis refused Emergency Medical Services (EMS), for medical evaluation.

Contact was then made with David Lazer Strugis. The defendant advised the following: He and his wife of less than a year, Mrs. Lazer Strugis, were involved in an argument because she believed he was cheating on her. The altercation was verbal and never became physical, as he only packed her belongings and moved them to her vehicle. The defendant did not have any marks that indicted physical violence. Based on the following investigation: I found probable cause exists for the arrest of David Lazer Strugis for Assault (Domestic), contrary to F.S.S. 784 03 1 (A)1
