- was found to have committed the below acts, resulting from my (described) investigation.

On the 9 day of February, 2021 at 17:10 (Specifically include facts constituting cause for arrest.)

On 02/09/2021 at approximately 1657 hours, I responded to the area of 226 Evernia St. in the Town of Jupiter, Palm Beach County, FL in reference to a motor vehicle crash. At the time, I was driving a fully-marked Jupiter Police Department patrol vehicle (vehicle 1425), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.

Dispatch advised the caller, later identified as the victim: Edgar Alvarez Chuc (w/m; 10/28/1982), advised the suspect vehicle, silver 1994 Toyota sedan FL tag # LMNH40, had tried to leave the scene and he had the vehicle blocked in, as he suspected the driver of the suspect vehicle was impaired.

Upon arrival, I made contact with Officer Bernstein who advised he arrived on scene and observed the silver Toyota being blocked in by a white Ford transit van. The Toyota was stopped in front of 226 Evernia St. (facing east). Officer Bernstein advised he made contact with the driver of the Toyota, Dawn Hoffman (w/f; 04/20/1962). He observed multiple indicators of impairment while speaking with Hoffman. Hoffman had to be advised multiple times to produce her license, registration, and insurance documentation. Hoffman had two opened bottles of liquor on the front passenger seat. See supplement from Officer Bernstein.

I next made contact with the victim. Alvarez Chuc advised he was stopped (facing south) on N Hepburn Ave. He was the second vehicle from the stop sign at S.R. 706 (W Indiantown Rd.). He stated the Toyota was traveling westbound on S.R. 706 turning right (north) on N Hepburn Ave. He advised the Toyota made a wide right turn, almost striking the vehicle in front of him, and the front driver side bumper of the Toyota struck the front driver side bumper of Alvarez Chuc's vehicle. He further identified Hoffman as the driver of the Toyota at the time of the crash. After the crash occurred, the Toyota continued north on N Hepburn Ave. and eastbound on Evernia St. where he blocked the

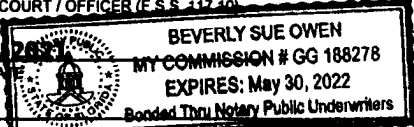

vehicle in, as he advised he believed Hoffman was intoxicated because she was swerving all over the road. He made contact with Hoffman and advised her eyes were watery.

I then made contact with Hoffman, who was standing outside her vehicle now, as Officer Ercolano had observed her drinking straight out of a bottle of Fireball Whiskey while she was waiting for me. I observed Hoffman had bloodshot/glassy eyes and detected the odor of an unknown alcoholic beverage on her person. I also observed Hoffman was swaying in a circular manner while I spoke with her. I advised Hoffman that Officer Andreasen had completed the crash investigation and I was beginning a criminal DUI investigation. I advised Hoffman her Miranda Warnings and confirmed she understood each one. Hoffman provided mostly short, one-word answers and it was difficult to detect any slurred speech.


Hoffman advised post-Miranda that she had not had anything to drink other than what officers on scene had observed. She further stated she felt as though she was under the influence.

I requested Hoffman complete Standardized Field Sobriety Tasks (SFSTs) and she refused. I advised Hoffman of her Taylor Warnings, confirmed she understood, and briefly explained each task so she aware of what she was refusing. I again asked if Hoffman was willing to complete SFSTs. Hoffman refused.

At this time, I placed Hoffman under arrest for DUI - Damage to Property and Leaving the Scene of a Crash at 1710 hours. At roadside, I requested Hoffman provide a lawful sample of her breath for the purpose of determining the alcohol content. Hoffman agreed at 1717 hours. Prior to transporting her to the Palm Beach County Breath Alcohol Testing Facility (BAT), I transported Hoffman to the Jupiter Medical Center for clearance, as she had been involved in a motor vehicle crash. I obtained clearance from the Jupiter Medical Center and arrived at the BAT at approximately 1843 hours.

I conducted a 20 minute observation period in which I did not observe Hoffman ingest or regurgitate anything. At the conclusion of the observation period, I requested Hoffman provide a lawful sample of her breath for the purpose of determining the alcohol content. Hoffman refused and I read her Implied Consent (excluding the CDL portion of Implied Consent). I confirmed Hoffman understood and again requested she provide a breath sample. Hoffman refused at 1913 hours.

Based on the aforementioned facts resulting from my investigation, I find Probable Cause exists to charge Dawn Hoffman with DUI - Damage to Property and Leaving the Scene of a Crash.

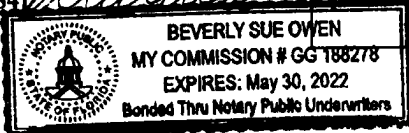

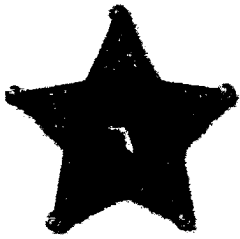
