Probable Cause

On 11/10/2019 at approximately 0145 Tampa communications center received a phone call in reference to a reckless driver in the area of County Line road and Kelly road in Spring Hill Florida. The witness advised the communication center that a red vehicle was all over the roadway, struck a curb and had an erratic driving pattern.

I was then dispatched to the area of County Line Road and Kelly Road where I received further information by the communication center that the vehicle was traveling southbound on Kelly road and was still obtained an erratic driving pattern. While in the area of Kelly road and Aubrey road, I observed the red pickup truck traveling west bound approaching the stop sign of Aubrey road to which the truck made an abrupt turn to the left continuing southbound on Kelly Road. The witness that was following this vehicle began to point at the truck that he was following. At this time, I began to follow the vehicle which was a 2005 red dodge pickup truck bearing Florida tag (4285BI). While following said vehicle I observed it to travel at a high rate of speed which was obviously faster than the speed limit.

The truck then proceeded northbound on Akins drive at a high rate of speed and began swerving into the southbound travel lane. The vehicle then turned off its lights while still on the roadway and turned into an unknown residence's driveway. At this time the vehicle then reversed out of said driveway and began to travel back southbound on Akins drive. At this time, I activated my overhead emergency lights and sirens on my marked patrol vehicle and conducted a traffic stop at the intersection of Akins road and Noon Ct. Contact was then made with the driver and sole occupant Dawn Persico. Dawn was explained the reason for the traffic stop to which she immediately became verbally combative. Dawn continued to be belligerent by raising her voice and trying to speak over me as well as using vulgar language. During this encounter I detected the strong odor of a consumed alcoholic beverage emitting her breath, slurred speech and blood shot watery eyes. Let it be known as she continued to speak over me the odor of the consumed alcoholic beverage became stronger.

I then asked Dawn for her drivers license which after an extensive period, this yielded with negative results. Therefore, I requested Dawn to exit the vehicle to which she became further verbally combative telling me she was not going to get out of her vehicle. I then opened her vehicles driver's side door to which she finally stepped out nearly losing her balance and leaned on her vehicle with her back.

I then asked Dawn if she would participate in field sobriety exercises, to which she refused immediately. Dawn was asked numerous times to conduct field sobriety exercises in order to dispel my suspicion of her impairment, and that I would have to make a judgment call based on the observations I already observed, to which she continued to become argumentative and continued to raise her voice and speak over me. Let it be known I observed Dawn to have unsteady balance.

I then placed Dawn under arrest for DUI based on my observations of her and placed her into the backseat of my patrol vehicle. While I was completing the tow sheet for her vehicle, Dawn slipped her

hand restraint and stuck her arm through my cage attempted to take her purse out of my front seat. At this time, I immediately reported to the back of my patrol vehicle and tried to gain control over Dawn. She continued to brace herself in her seat and would not allow myself and other troopers on scene to gain control over her to which she was escorted to the ground outside the patrol vehicle. While I was attempted to place the hand restraint on her right wrist, she continued to pull her arm away and brace it underneath her upper body. She also continued to try and grab onto the hand restraint to prevent arrest.

Dawn was transported to the Pasco County Jail. Let it be known during transport Dawn was verbally aggressive and belligerent. Dawn was subsequently turned over to Jail staff. During the twenty-minute observation period Dawn continued to become belligerent and use vulgar language towards me. Dawn was read her Miranda warnings at 0303 to which she also invoked at the same time and advised she did not wish to speak to me. Dawn was requested to provide a breath sample to which she refused. She was read implied consent at approximately 0310 hours and continued to refuse to provide a sample of her breath.

Dawn was issued a bond totaling \$3,000 and was issued DUI citation (A76U4BE) and uniform traffic citation (ABIWZKE) for failure to use designated lane. All the events listed above took place in Pasco County Florida.
