On 08/14/2020, at approximately 0122 hours, Deputy Berona was traveling west on Waters Av W, just west of Dale Mabry Hwy

N. As he was driving, he observed a silver Ford Explorer travelling toward him head-on without headlights activated during night hours. Just before striking his vehicle, the silver Ford jumped the raised median to enter the correct direction of travel.

Deputy Berona immediately conducted a U-turn and conducted a traffic stop at the intersection of Waters Av W / Blossom Av

on a 2002 silver Ford Explorer bearing FI tag IBDZ79 (VIN:1F-MZU/3E2ZUB43020). Deputy Berona observed the defendant operating the vehicle and detected signs of impairment. Affiant responded to the scene, detected signs of impairment, and

requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the

defendant showed signs of impairment and was subsequently arrested. After a proper 20 minute observation, the defendant provided a lawful breath sample that resulted in a BAC of .145/.144. The defendant was identified via FL DL.
