The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 08/21/2020 at 2258 hours I conducted a traffic stop on a gray 2015 Audi A3 sedan, FL tag UN55D for speeding, 60 MPH in a posted 40 MPH zone, eastbound on Kennedy Bl W from MacDill Av S. Upon contact with the driver of the vehicle, defendant Dean Patrick Samartin, I observed that he had bloodshot glassy eyes and as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. Then as I continued to speak with him I further observed that his responses to my questions were delayed and that he appeared to be confused. The defendant then refused to perform to the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 2305 hours. I then transported the defendant to the HCSO/CBT Facility where he refused to submit to a breath test. Implied Consent was read at 2332 hours. I identified the defendant with a valid FL DL. He was the only one in the vehicle.
