at approximately 1:11 AM, at 9980 GULF BLVD, TREASURE ISLAND, FL 33706, in Pinellas County did:

KNOWINGLY AND WILLFULLY, RESIST, OBSTRUCT OR OPPOSE OFFICER INNES, A DULY AND LEGALLY CONSTITUTED LAW ENFORCEMENT OFFICER OF THE TREASURE ISLAND POICE DEPARTMENT, BY OFFERING OR DOING VIOLENCE TO SAID OFFICER WHO WAS LAWFULLY ATTEMPTING TO PLACE THE DEFENDANT INTO PROTECTIVE CUSTODY UNDER THE MARCHMAN ACT. DEFENDANT DID INTENTIONALLY KICK THE LAW ENFORCEMENT OFFICER DURING THE LAWFUL DETENTION AT 9980 GULF BLVD.

DEFENDANT WAS ADVISED TO HAVE BEEN SLEEPING IN THE ELEVATOR OF THE ABOVE LOCATION BY COMPLAINANT. THE EMPLOYEE CALLED THE POLICE WHEN THE DEFENDANT BECAME VERBALY HOSTILE. THE DEFENDANT THEN LEFT THE LOCATION AND WALKED OUTSIDE, WHERE OFFICERS LOCATED HER. THE COMPLAINANT TOLD THE DEFENDANT SHE WAS TRESPASSED. THE DEFENDANT LUNGED AT THE EMPLOYEE, AND THE OFFICERS TOOK THE DEFENDANT INTO PROTECTIVE CUSTODY DUE TO HER INTOXICATED STATE AND ACTIONS. WHILE PLACING THE DEFENDANT INTO THE PRISONER COMPARTMENT OF THE PATROL VEHICLE, THE DEFENDENT BEGAN BRACING, TENSING, PUSHING, AND PULLING, AND AT ONE POINT KICKED BACKWARDS WHILE YELLING AND STRUCK OFFICER INNES IN HIS RIGHT KNEE WITH HER LEFT FOOT. OFFICER INNES WAS IN FULL POLICE UNIFORM AT THE TIME OF THE BATTERY. THE BATTERY RESULTED IN NO APPARENT INJURY TO OFFICER INNES.
