The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/14/2020, at approximately 2303 hours, at Waters Av. W. / Dale Mabry Hw. N., Tampa, FL 33614, Corporal Brito (ABN 247308) conducted a traffic-stop on a white Dodge Challenger (bearing FL tag Z691WV / VIN: 2C3CDZAG1GH352788) after observing the vehicle exit a parking lot, drive east in the westbound lanes of Waters Av., then correct by jumping the center divider onto Waters Av. E. Upon making contact, Corporal Brito observed the defendant to have watery eyes, slurred speech, and she fumbled locating the requested vehicle documentation. She also admitted to coming from a wedding and recently having a drink. Based on the observed indicators of impairment, Corporal Brito requested a DUI investigator respond to the scene. Upon my arrival, I observed the same indicators of impairment listed above, as well as detected the odor of an alcoholic beverage emitting from the defendant's breath, and observed her eyes to be bloodshot and watery. Post Miranda, she also admitted to consuming approximately 3 glasses of wine within the last few hours. The defendant was given the opportunity to perform field sobriety exercises, which she did poorly, indicating impairment. Subsequent to arrest, the defendant provided breath samples of .167/.163 after a twenty minute observation period. The defendant was identified via their Florida driver's license.
