The victim 1 (Armed Security Guard) had received a report of a female passed out behind the wheel of a vehicle. Victim 1 located the defendant passed out in a blue 2016 Chevy Malibu bearing FL BYGX28. The victim asked the defendant several times to get out of the vehicle. Finally, the defendant exited the vehicle. Victim 1 asked the defendant to move towards the front of the vehicle. Victim 1 started to escort the defendant towards the front of the vehicle when the defendant spun around and struck the victim in the left upper chest area with the defendant's right elbow. After the strike, the defendant went to grab victim 1 with her hands.

Victim 2 (TPD Officer) arrived on scene to assist victim 1. Victim 2 witnessed the defendant grabbing victim 1 and pushed her into the concrete wall. Victim 1 then put the defendant in a hold and bent across the trunk of the vehicle. When victim 2 grabbed the right arm of the defendant to place her into custody, the defendant kicked victim 2 in the leg below the right knee with her foot.

Victim 1 was wearing	a uniform with insignia on each shoulder and her security badge on the upper left front of her shirt.
Victim 2 was wearing	her TPD issued Class B uniform with insignia with her TPD issued badge.

Victim 1 and 2 did not sustained any injuries during the incident.

The defendant was ID via FL/DL.
