The defendant was driving her 2018 Lexus 4-door, bearing FL tag #IQUU45. Upon making contact with the defendant, she displayed multiple indicators of impairment, including slurred speech, a strong odor of an alcoholic beverage on her breath, bloodshot/glassy eyes, sluggish reflexes, unsteady on her feet, crying from apparent reason, admission to "drinking too much", and a spontaneous admission that "she shouldn't have been driving". The defendant refused to perform the SFSEs and was arrested for DUI. The defendant also refused to submit to the breath test, despite acknowledging the Implied Consent Warning. The defendant identified herself via her FL driver's license.
