

ON 02/15/2020 AT APPROXIMATELY 1507 HOURS, I WAS DISPATCHED TO 3894 KEWANEE ROAD IN UNINCORPORATED LANTANA FLORIDA 33462 IN REFERENCE TO A DISTURBANCE. DISPATCH ADVISED A FEMALE WAS REPORTING THAT HER BOYFRIEND'S EX WIFE STRUCK HER WITH A ROCK. UPON ARRIVAL, I MADE CONTACT WITH THE COMPLAINANT, SAMANTHA LUCAS, WHO ADVISED OF THE FOLLOWING:

HER BOYFRIEND'S EX WIFE, DENE A EGENLAUF, LIVES ACROSS THE STREET FROM HER AND HER BOYFRIEND. TODAY HER BOYFRIEND'S SON, NATHAN CANTU, WHO PRIMARILY LIVES WITH HER WANTED TO GO VISIT EGENLAUF. LUCAS TOLD CANTU THAT SHE COULD GO SEE HIS MOTHER. CANTU WENT BACK AND FORTH SEVERAL TIMES BETWEEN THE TWO HOUSEHOLDS. SINCE CANTU USUALLY STAYS WITH LUCAS AND HER BOYFRIEND MOST OF THE TIME, LUCAS TOLD CANTU TO GO SPEND THE NIGHT WITH EGENLAUF TO SPEND TIME WITH HER. SEVERAL MINUTES LATER, EGENLAUF CAME TO THE RESIDENCE AND BEGAN BANGING ON THE FRONT DOOR YELLING. WHEN LUCAS OPENED THE DOOR, SHE CAME FACE TO FACE WITH EGENLAUF WHO BEGAN YELLING AT HER THAT CANTU WANTED TO COME HOME. LUCAS EXPLAINED TO EGENLAUF THAT SHE WANTED CANTU TO STAY AT HER RESIDENCE BECAUSE HER BOYFRIEND HAD A TOOTH PULLED AND NEEDED TO REST. IT WAS AT THAT TIME, EGENLAUF GRABBED A ROCK IN FRONT OF THE HOUSE, PRESSED IT AGAINST LUCAS' FACE AND PUSHED HER INTO THE HOUSE WITH IT. LUCAS BEGAN SHUTTING THE DOOR WHEN EGENLAUF HIT THE ROCK AGAINST THE DOOR. THIS IS AN ONGOING ISSUE BETWEEN THE TWO OF THEM. LUCAS STATED SHE COULDN'T TAKE IT ANYMORE SO SHE CALLED THE POLICE AND WANTED TO PRESS CHARGES. I OBSERVED REDNESS AND A QUARTER SIZE LUMP ON THE LEFT SIDE OF LUCAS' FOREHEAD WHERE SHE CLAIMED TO BE STRUCK WITH THE ROCK. PHOTOGRAPHS WERE TAKEN.

I MADE CONTACT WITH EGENLAUF WHO STATED "SHE CALLED AND SAID I HIT HER IN HER FACE DIDN'T SHE?" SHE CONFIRMED SHE HAD GONE OVER TO SPEAK WITH LUCAS BUT DENIED ANY PHYSICAL ALTERCATION. SHE STATED THEY HAD GOTTEN IN EACH OTHERS FACES BUT THAT NEITHER PLACED A HAND ON THE OTHER. BASED ON MY INVESTIGATION AND THE STATEMENTS OF ALL PARTIES, I HAVE REASON TO BELIEVE AND DO BELIEVE THE DEFENDANT, DENE A EGENLAUF, VIOLATED F.S.S 784.03(1A1); BATTERY.
