Turney stated that he witnessed a disturbance between two subjects at the bar but they both left prior to my arrival.

Shortly after, I observed a female matching the description given earlier, walking in the parking lot, crying. She identified herself via FL DL as Denise Suzanne Williams (W/F DOB: 09/10/1972). Williams appeared to be intoxicated and highly emotional. Once Williams started to become less emotional and able to speak, I provided her with her Miranda Rights from an agency issued card, which she stated she understood.

Post Miranda, Williams stated that she met her on and off again boyfriend, Troy Randall Fike (W/M DOB: 06/26/1981) at the Topside Bar earlier that day because she wanted to retrieve items that belonged to her that were inside his pick-up truck. Williams stated that she and Fike have been dating on and off for approximately six years but that they are currently not dating. She then stated that while sitting at the bar with Fike, he took her car keys away from her, as he did not want her to drive. Williams then stated that she proceeded to throw her drink at Fike. When I questioned her on whether she threw the liquid contents or the actual glass at Fike, she stated that she threw the drink and possibly also threw the glass. Williams stated that Fike left the bar following this incident. She attempted to follow him out to his vehicle but he left the parking lot before she was able to. Fike left the scene prior to my arrival.

While I spoke to Williams, a subject approached Officer Raleigh and identified herself as off-duty PBSO Deputy Kelsey Shults. Deputy Shults state that she witnessed Williams strike Fike and throw a glass but that she did not see the glass make contact with Fike. At this time, Officer Raleigh proceeded to review surveillance footage from bar which showed an argument between Williams and Fike. Williams is then seen pushing and slapping Fike before picking up a rock's glass and hitting him in the head with it. (See Officer Raleigh's supplemental report).

While with Williams, she received a phone call from Fike. I then proceeded to speak to Fike via phone call. I asked Fike where he was and stated that I wished to meet with him to discuss the events that had transpired earlier that day. Fike was very hostile and stated that law enforcement was not allowed where he currently was and that he would not be meeting with anyone because he believed that he would get arrested. When asked about what occurred at Topside Bar, Fike stated that Williams hit him in the head with a glass, and that he believed he has a concussion. I once again asked Fike to meet me to further discuss the incident, which he declined but stated that he wishes for Williams to be arrested.

Due to the aforementioned statements, my investigation and video surveillance, I established probable cause to charge and arrest Denise Suzanne Williams with Aggravated Battery pursuant to F.S.S 784.045(1)(A)(1)(2) as she intentionally struck Fike with a glass against his will.

At approximately 2032 hours, Williams was placed under arrest. She was placed in handcuffs that were double locked and checked for spacing.

Officer Raleigh conducted a search of Williams before she was transported to the Jupiter Police Department for processing.

While at the Jupiter Police Department, Williams advised Officer Raleigh that she had injuries from a separate incident from a different day and that she wished to be medically evaluated. I then transported Williams to Jupiter Medical Center for further evaluation.
