


<p><b>The following incident was captured utilizing my department issued BWC.</b></p> <p>On Saturday December 25, 2021 at approximately 2209hrs, I responded to 129 Bishopwood Dr in reference to an active fight between two males. Upon arrival, I was directed to the garage of the residence, where I observed two males on top of each other, on the ground; one holding the other down. The man on the bottom was later identified as Dennis O'Brien (WM 9/28/1975 - Offender) and the male holding him down was later identified as Ray Sutton (WM 6/25/1961 - Victim).</p> <p>I separated the males and had the victim wait inside the house, while I spoke with the offender. The offender stated he stopped by the house to see his kids, as they were currently with their mother, Kimberly Filion (WF 7/7/1975) who resides at this residence. When he entered the home, he was confronted by the victim who allegedly grabbed the offender by the wrist. When he grabbed his wrist, the offender punched the victim in the face numerous times. The offender was less than forthcoming with information.</p> <p>I next spoke with the victim who stated he was sitting out in the garage when the offender came through the door, charged at him and punched him in the face. The victim's son, Austin Sutton (WM 7/19/2002) stepped in to help get the offender off of the victim. The victim was able to gain control of the offender and held him on the ground until the arrival of officers.</p> <p>I spoke with A. Sutton who stated he observed the offender charge into the garage, where he knew the victim was. A. Sutton felt like something was off and followed the offender into the garage, where he observed the offender punch the victim in the face with a closed fist numerous times. A. Sutton stepped in to stop the offender from hitting the victim and was able to separate the two men. A. Sutton and the victim controlled the</p>

offender so he could no longer hit anyone, and waited for the arrival of police.

I spoke with a witness, Jamie Ciscle (WF 4/11/79) who provided a video of the incident. When viewing the video, I observed the offender, wearing a grey tee shirt and light grey shorts charge into the garage area. The victim, wearing blue jeans and a dark grey shirt, was sitting in a chair in the garage. The offender approached the victim in an aggressive manner, and began striking the victim in the face with a closed fist. The offender continued to strike the victim in the face until A. Sutton was able to grab the offender and pull him off of the victim. A. Sutton took the offender to the ground as the offender still tried to throw punches at the victim. A. Sutton and the victim were able to secure the offender and prevent him from further attacking anyone. The victim held the offender on the ground until the arrival of police.

All involved individuals declined medics, and the victim sustained minor injuries to his mouth/lip, which were captured via BWC. Video of the incident was uploaded to JPD Evidence.com.

Based on the aforementioned statements, the video evidence and as a result of my investigation, probable cause has been established to arrest Dennis O'Brien for Battery, pursuant to F.S.S. 784.03(1)(A)(1). O'Brien was taken into custody and placed into handcuffs, which were double locked and checked for fit. He was transported to Jupiter Police holding while the proper paperwork was completed and subsequently turned over to PBCJ.
