 On the 30 day of August, 2020 at 02:36 (Specifically include facts constituting cause for arrest.)

On August 30th 2020, at approximately 0050 hours, I responded to the intersection of US HIGHWAY 1, and E Indiantown Rd, reference to a vehicle versus pedestrian crash.

While on my way to the scene, dispatch advised the vehicle involved fled southbound, and described it as a white sedan. Upon my arrival, I observed a Hispanic male on the southwest corner of the intersection holding his left arm and grimacing in pain. The Hispanic male could not communicate in English, and he was ultimately taken to St Mary's by Palm Beach Fire Rescue with possible internal injuries. The Hispanic male was ultimately identified as Jose Ricardo Jacinto Diaz 6/7/88, via a Guatemalan Identification Card found on his person.

On scene, the witness and complainant, Kyle James Ripple 4/30/97, gave the following account; Ripple was stopped at E Indiantown Rd and US HIGHWAY 1, in the far right turn lane to turn south on US HIGHWAY 1. Ripple observed a Hispanic male run into the middle of the southbound lanes of US HIGHWAY 1 without the right of way (STOP SIGN ON CROSSWALK), and that is when a white sedan described as having black rims and black side view mirrors that was traveling southbound on US HIGHWAY 1, crashed into the pedestrian. Ripple stated the Hispanic male came into contact with the passenger side of the white sedan, and a black mirror was found on scene in the roadway. Ripple stated the vehicle did not attempt to stop and render any sort of aide, and continued southbound on US HIGHWAY 1.

An officer BOLO was put out for the suspect vehicle at 0057 hours, and at 0103 hours, Officer Gundlach located a sedan missing its passenger side view mirror, matching the description provided, traveling westbound on Donald Ross Rd. The vehicle, a white Infinity Q50 bearing FL tag HXIA55, ultimately pulled into a parking spot to the rear of 221 Greenwich Cir. The time frame from when the BOLO was put out, to when Officer Gundlach observed the vehicle (six minutes), was a reasonable amount of time to get from

the accident to where the vehicle was located.

The driver of the vehicle was identified as Derek P Vanhose 4/29/82. Prior to reading Vanhose Miranda Warnings, I asked him if he knew why there was such a large police presence around his vehicle. Vanhose stated, "because of Indiantown and US HIGHWAY 1". I then read Vanhose his Miranda Warnings, and he stated he did not want to speak with me without a lawyer present. I then spoke to both passengers that were in the vehicle.



Front right passenger was identified as Gregory L Winger 7/13/61, and he stated as the vehicle was traveling southbound on US HIGHWAY 1, the vehicle hit an unknown object at the intersection of E Indiantown Rd. Winger stated the occupants were not sure what they hit, but stated they did not stay in the area long enough to find out.

Rear right passenger was identified as Michael J Vota 1/25/85. Vota stated the vehicle had the right of way, and that they did not stop, because they needed gas. Vota stated they planned to call the police when they got gas. They never stopped for gas, and never called the police.

It should be noted that the parking spot the vehicle pulled into (rear of 221 Greenwich Cir), was not anyone in the vehicle's destination, and the vehicle nor the occupants had any reasonable explanation as to why they parked there. Vota and Winger left the scene in an uber, and Vanhose's vehicle was ultimately towed from the scene.

Vanhose was subsequently taken into custody reference to leaving the scene of an accident causing injury, and was ultimately transported to the Palm Beach County Jail without incident.

Vanhose did drive a motor vehicle involved in a crash that occurred on public or private property which resulted in injury other than serious bodily injury to victim, Jose Ricardo Jacinto Diaz, and Vanhose did willfully fail to immediately stop the vehicle at the scene of the crash or as close thereto as possible, or did willfully fail to remain at the scene of the crash until he fulfilled the requirements of Florida Statute 316.062, contrary to Florida Statute 316.027(2)(a).
