The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On listed date, time, and location, I stopped the suspect's vehicle for swerving on the roadway, unable to maintain a single lane of travel. While speaking with the subject, I observed him to have multiple signs of possible impairment (slow movements, fumbling with documents, bloodshot watery eyes, odor of alcohol, incorrect statements.) I removed the subject from his vehicle and continued to observe signs of possible impairment from him outside the vehicle. The subject agreed to perform HGN on-scene and performed poorly. I requested to transport the subject off the interstate for FSEs. The subject stated that he did not feel comfortable with the situation. I informed the subject that if he refused to perform the other two exercises, I would be forced to base my arrest decision on the signs of possible impairment observed thus far. The subject consented to being transported off the interstate for FSEs (WAT and OLS.) The subject performed poorly on all FSEs and was placed under arrest for DUI. While at CBT, I requested the subject provide a sample of his breath. The subject stated that he would not provide a sample of his breath unless his attorney advised him to do so. I read the subject implied consent in a recorded room. The subject again stated that he would not provide a breath sample unless advised by an attorney. The subject was booked and processed into Orient Road jail.

This incident occurred within Hillsborough County.
