The affiant observed the defendant in the driver seat and sole occupant of the vehicle, with the keys in the ignition. Upon contact with the defendant, he had slurred speech, he was disoriented, he had lethargic movements, he had bloodshot and watery eyes, and an unstable balance. Some field sobriety exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples. The first BrAC sample was .000 and the second BrAC sample was .000. Based on the BrAC results not matching the impairment observed on scene, the affiant requested the defendant provide a urine sample, which he refused after Implied Consent was read and understood.
