The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On July 26, 2020 at approximately 1730 hours, two citizen complainants called H.C.S.O. regarding a "single vehicle flipped and hit a tree." Master Deputy Reichert (ABN:4703) responded to the scene and observed the defendant seated immediately outside a white Ford Fusion bearing Florida tag: Y28QDD (V.I.N.:3FA6P0G71HR154629) which was flipped on its driver side. The vehicle is registered to the defendant. On contact with the defendant, Deputy Reichert observed a seatbelt abrasion on his torso consistent with operating a motor vehicle as a driver. In addition, blood on the driver side door, airbag, and exit points were consistent with the blood and lacerations on the left side of his body. As Deputy Reichert was speaking with the defendant he detected indicators of impairment to include; bloodshot glassy eyes, slurred speech, mood swings from angry to crying, unsteadiness on his feet, and the strong and distinct odor of an alcoholic beverage emanating from his breath. Deputy Brannum investigated the traffic crash under H.C.S.O. Case #20-482671 (DHSMV#89436654) and estimated the total damages of the traffic crash at approximately \$25,500 to include damage to a county road sign. The affiant responded to the scene and observed the aforementioned indicators of impairment as well as an orbital sway while standing. The affiant requested the defendant perform field sobriety exercises which he agreed to do. Throughout the performance of the exercises, the defendant displayed indicators of impairment and was subsequently arrested for Driving Under the Influence. The defendant was transported to Central Breath Testing where after a proper twenty-minute observation period was conducted, he provided two lawful breath samples of .198/.203% B.A.C. respectively. The defendant identified himself verbally and his identity was confirmed via Florida Driver License which was located in the center console of the Ford.
