The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 07 day of MAY, 2020,

at approximately 8:09 AM, at 8901 PARK BLVD N, in Pinellas County did:

UNLAWFULLY USE OR HAVE IN HER POSSESSION, CUSTODY, OR CONTROL A CERTAIN ITEM OF DRUG PARAPHERNALIA WITH THE INTENT TO USE SAID PARAPHERNALIA FOR UNLAWFULLY SMOKING, INGESTING OR INJECTING A DANGEROUS DRUG CONTROLLED BY CHAPTER 893 OF FLORIDA STATE STATUTES INTO THE HUMAN BODY, TO-WIT: A SMALL BLUE GLASS PIPE.

TO-WIT: MICHAEL AND DEVON WERE OBSERVED DRIVING RECKLESSLY ON PARK STREET SOUTH OF PARK BLVD. PER THE COMPLAINANT THE SUBJECTS IN THE RECKLESS VEHICLE WERE OBSERVED SMOKING FROM A PIPE AS THEY WERE PULLING INTO THE PARKING LOT OF MCDONALDS. UPON CONTACT WITH THE DRIVER AND PASSENGER "DEVON NOELLE CHILDERS" I OBSERVED A GLASS PIPE IN PLAIN VIEW ON THE PASSENGER SEAT WHERE DEVON WAS SITTING. UPON CONDUCTING A SEARCH OF MICHAEL A GLASS PIPE WAS FOUND IN HIS PANTS AND A SMALL BAG CONTAINING A CRYSTAL LIKE SUBSTANCE WHICH TESTED POSITIVE FOR METH. POST MIRANDA MICHAEL STATED THE METH AND PIPE FOUND ON HIS PERSON WAS HIS; HOWEVER, THE GLASS PIPE FOUND ON THE PASSENGER SEAT WAS NOT. 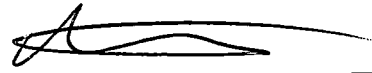
ADVISORY AND SOLVENCY HEARING

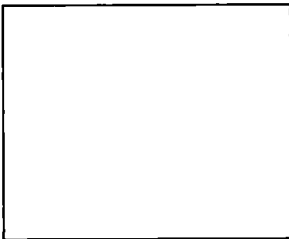
