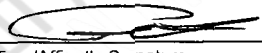
Before me this date personally appeared PLUTA, DARIUSZ (17299) who being first duly sworn deposes and says that on 22 day of April (year) 2017 at 2800 E ATLANTIC BLVD, POMPANO BEACH, FL 33062 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

Atlantic Blvd) facing in a southern direction Moments prior, I spoke to Deputy Tobias Andrews (CCN# 14523) via cell phone while en-route to the scene Deputy Andrews stated that he responded to a vehicle accident at this location While there and speaking with Driver 1 (D1) - Diana J Richardson (W/F) of Vehicle 1 (V1), there was an odor of an alcoholic beverage emanating from her breath, and slurred speech was also noticed I was told that during his investigation, the other driver/`Wheel` Witness - (W/F) of Vehicle 2 (V2), positively identified Richardson as the driver of V1, she was no longer present for me to speak with myself though After these indicator(s)/factor(s) were seen/observed, I was requested to the scene A DUI Supplemental Report was completed, and CSA Elizabeth Nunez (CCN# 18114) conducted the Accident Investigation; see those Reports for further details and information. Pompano Beach Fire-Rescue did not respond as all involved refused any/all medical attention, evaluation, treatment, or transport to the hospital; no apparent injuries were seen either

Once the accident investigation was completed, I then spoke to Richardson - who was identified by her Florida Driver's License I explained to her that I am now conducting a DUI (Driving Under the Influence) investigation, she verbally acknowledged that she understood Talking with Richardson, I immediately noticed/observed red, glossy, blood-shot eyes, slightly slurred speech, repetitive sentences/statements (information already relayed/talked about - kept saying that the accident was not her fault and that the other driver was lying), and a strong smell of an unknown type of alcoholic beverage emitting from her breath/facial area Watching Richardson, she was slightly unsteady on her feet at times (swaying), and also dropped some paperwork at one point

Before me this date personally appeared PLUTA, DARIUSZ (17299) who being first duly sworn deposes and says that on 22 day of April, (year) 2017 at 2800 E ATLANTIC BLVD, POMPANO BEACH, FL 33062 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

I then asked Richardson where she was coming from and heading to she stated from the Publix on E Atlantic Blvd, Pompano Beach, and heading home She said that she initially left her residence at approximately 1600 hours this day, stayed at Publix for about an hour or two, and then started driving home again. However, she also advised that the vehicle accident occurred at approximately 1600 hours after leaving the Publix store - inconsistent with the previous answer(s)/statement(s)

I asked her if she has had any alcoholic beverages today, and she advised that she did not While en-route to the B A T though, Richardson spontaneously uttered that she forgot that she had an unknown size 'Pina-Colada' at approximately noon/1300 hours this day She said that she last ate at approximately noon/1300 hours; turkey sandwich at her home Lighting conditions were good, as it was still daytime The weather was clear - not raining and the ground was dry, Richardson was wearing sandal/flip-flop type of footwear

In asking reference medical conditions, Richardson said that she has had surgery last November for a hysterectomy, does currently [REDACTED] and her [REDACTED] (last taken this morning), and does not have asthma or diabetes, nor any other medical condition(s) that I need to be aware of Richardson was not wearing glasses, and advised that nothing hurts on her body at this time Speaking further with her in order to inquire if she will submit to Field Sobriety Exercises, she agreed

HGN (Horizontal Gaze Nystagmus) Exercise (6/6 Clues) After instructions were explained, Richardson acknowledged she understood; (Equal tracking / Equal pupil size / No resting nystagmus)

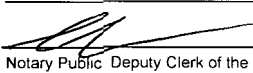

- (1/2) Lack of smooth pursuit in both eyes
(3/4) Eye-nystagmus distinct and sustained at maximum deviation in both eyes
(5/6) Onset of eye-nystagmus distinct prior to 45 degrees in both eyes

Richardson kept continuously moving her head throughout the exercise. Vertical Nystagmus was not seen

Walk & Turn Exercise (6/8 Clues), using the second (from the East), white, parking spot line on the south portion of the parking lot. After instructions of the exercise were demonstrated/explained, Richardson verbally acknowledged she understood

Instruction phase

- (1) Cannot keep balance (separated her feet from the starting position that she was in)

Walking Phase

- (2) Stops while walking (after the 9th step 'Forward', could not remember what to do next)
(3) Misses heel to toe (several times throughout the exercise), slid her heel to toe at times, otherwise canted
(4) Uses arms to balance (raises arms over four-six inches)
(5) Improper turn (never turned to the left as demonstrated - initially turned to the right instead of left, then continued turning to the right until a full circle was completed)

- (3) Puts foot down (before 30 seconds elapsed) - attempted all with right leg raised, places foot down numerous times

Finger to Nose Exercise: (2/4 Clues) After instructions were explained, Richardson verbally acknowledged that she understood

- (1) If finger other than index finger touches the nose or if index finger does not touch nose, regardless of how many times
- (2) Fails to return arms to the side (remove finger from nose) - on first 'Left', kept her finger on nose area

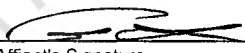
After beginning, Richardson had extremely fast arm movements, and never extended her arm out as demonstrated

Romberg Balance Exercise: (2/4 Clues) After instructions were explained for a 30 second internal count, Richardson verbally acknowledged that she understood

- (1) Swaying (slightly)

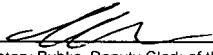

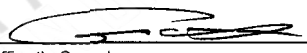

(2) Count to 30 (+/-5)

First attempt, Richardson advised to stop at 22 seconds, second attempt, 33 seconds, and third attempt, 30 seconds. She attempted to start the exercise several times while I was still demonstrating Afterwards, she began counting out-loud until re-instructed to count internally She also did not lean her head completely back as asked

Based on my observations, Richardson was arrested for suspicion of DUI She was later issued a Florida DUI Uniform Traffic Citation for F S S 316 193-2A2A / DUI ALCOHOL OR DRUGS 1ST OFFENSE. After arriving at the BSO BAT (Breath Alcohol Testing) Facility, Richardson was placed on video and Florida Implied Consent was read. She was requested to submit to a breath test, which she agreed to, the Technician assigned was Frazier (CCN# 14364) Richardson provided two breath samples with the following results First sample 111g/210L, Second sample 101g/210L She also completed the Standardized Sobriety Exercises on video while at the B A.T Richardson was additionally issued one other Criminal Florida Uniform Traffic Citation for F S S 316 193-3C1 / DUI W/DAM TO PROP OR PERSON OF ANOTHER, along with a regular U T.C for F.S S 316 085-2 / IMPROPER CHANGE OF LANE - PULL IN FRONT OF VEH SAME DIRECTION

Ultimately, Richardson was transported to the Broward County Main Jail and custody was transferred over to the facility staff Her vehicle was towed by Emerald's Towing from the scene, BWC in use

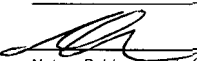
