The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 13 day of MAY, 2020,

at approximately 9:31 AM, at 11469 82ND AVE, SEMINOLE, FL 33772, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE STEVEN CLAUSS, HER BOYFRIEND AND CO-HABITANT, AGAINST THE WILL OF STEVEN CLAUSS, TO WIT: DEFENDANT THREW CLEAR GLASS WITH HOT WATER AT VICTIM.

ON THE ABOVE DATE AND TIME, THE DEFENDANT AND VICTIM WERE ARGUING ABOUT COMMUNICATION IN THEIR RELATIONSHIP. THE DEFENDANT WAS FOLLOWING THE VICTIM THROUGH THE HOUSE CONTINUING THE ARGUMENT. THE VICTIM BEGAN MAKING COFFEE IN THE KITCHEN, AND THE DEFENDANT THREW A CLEAR GLASS OF HOT TEA AT THE VICTIM. THE LIQUID HIT THE VICTIM'S RIGHT LOWER SIDE, AND THE GLASS MISSED HIM, HITTING THE OVEN GLASS, SHATTERING THE GLASS.

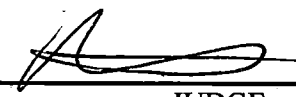
ADVISORY AND SOLVENCY HEARING

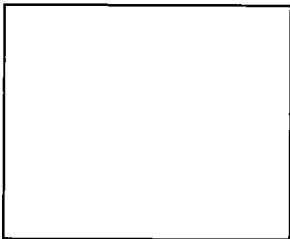
