The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/23/2021 at approximately 2130 hours, Affiant conducted a vessel stop on a white 2021 Tahoe center console bearing FL4480SS / Hin: BUJ60807H920 within 1 Garrison Channel Tampa, Hillsborough County , FL 33606 for Idle/Slow speed violation (V374685). Upon stopping the vessel, Affiant made contact with the operator/defendant, who was sitting at the helm with his hands on the steering wheel. During personal contact with the defendant, affiant observed blood shot watery eyes and detected an odor of an alcoholic beverage coming from his breath as he spoke.
