The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 10 day of FEBRUARY, 2020,

at approximately 10:56 PM, at 1696 CORAL WAY UNIT B, in Pinellas County did:

WHOEVER COMMITS ANY CRIMINAL OFFENSE AGAINST THE STATE, WHETHER FELONY OR MISDEMEANOR, OR AIDS, ABETS, COUNSELS, HIRES, OR OTHERWISE PROCURES SUCH OFFENSE TO BE COMMITTED TO WIT;

THE DEFENDANT ARRANGED A MEETING WITH THE VICTIM AT HIS RESIDENCE, TELLING THE VICTIM THEY WERE GOING TO "HANG OUT" AND CONSUME MARIJUANA. THE DEFENDANT WENT TO THIS LOCATION WITH THE PLAN TO COMMIT ROBBERY BY TAKING THE SUBJECTS MARIJUANA BY FORCE. THE DEFENDANT CARRIED OUT THIS PLAN, AND MET WITH THE SUBJECT AT HIS HOME, INSIDE OF HIS BEDROOM. ANOTHER SUBJECT WHO WAS WITH THE DEFENDANT SIGNALLED SEVERAL OTHER MALE SUBJECTS, WHO THEN FORCEFULLY ENTERED THE REAR DOOR OF THE HOME. ONE OF THESE OTHER SUBJECTS PUNCHED THE VICTIM, AND PRODUCED A FIREARM. THE SUBJECT POINTED THE FIREARM AT THE VICTIM AND DEMANDED "EVERYTHING IN HIS POCKETS." THE DEFENDANTS POCKETS WERE EMPTY. ONE OF THESE SUBJECTS TOOK THE VICTIM'S PHONE, WHICH WAS CHARGING ON HIS BED. THE DEFENDANT AND THE REST OF THE SUBJECTS THEN FLED THE SCENE. THE DEFENDANT ADMITTED TO GOING TO THIS HOME WITH THE INTENT TO COMMIT THIS CRIME POST MIRANDA. THE DEFENDANT DENIED PLANNING THIS.

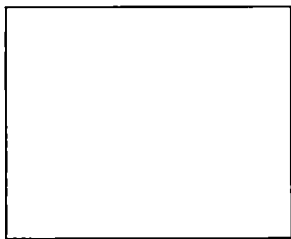
