The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On February 16, 2020, at approximately 0538 hours, the defendant was operating a white in color, four door, Ford F-150, bearing FL tag 1019VX near the intersection of Sligh Av. W. and Habana Av. N. The defendant operating this truck crashed into another vehicle causing approximately \$4000.00 dollars in property damage. The witness positively identified the defendant as the person operating the Ford truck at the time of the crash. The affiant responded to the scene and detected multiple signs of impairment, such as, glossy blood shot eyes, slurred and slow speech, swaying, and smelled the odor of an alcoholic beverage emitting from his breath. The affiant requested that the defendant perform the SFSE's which he willingly agreed to do. During the performance of the SFSE's, the defendant continued to show signs of impairment, and was subsequently arrested of DUI/w property damage. Upon arrival to CBT, the defendant refused to provide a lawful sample of his BrAC after being read implied consent. The defendant was positively identified via his FL DL and was provided with one uniform DUI citation, which reflects the DUI charge.
