The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was observed driving a black 2017 Nissan 4-door (FL TAG #MONK2) northbound on 21st St N at 6th Av E. This area of 21st St N is a 1-way road with southbound traffic only and the defendant was driving head-on into traffic. During the traffic stop for the infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, droopy eyelids, blank/dazed stare, slurred speech, fumbling fingers, slow deliberate movements, admitted to drinking "way too much to drive since 4pm", and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance during SFSEs. While at CBT, he was read Implied Consent and refused to provide a breath sample.
