The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On April 16, 2020, at approximately 1337 hours, a white male was observed driving a white Jeep, bearing Florida tag Y98VDC, traveling east bound on Interstate 4. The listed driver/vehicle was unable to maintain his lane, which was being observed by a concerned citizen. While dispatch updated the whereabouts of the vehicle, Deputy Gipson #145281 observed the white Jeep, who continued east bound, committing the traffic offense of failure to maintain his lane. Based on that violation, Deputy Gipson conducted a traffic stop. Deputy Newman #5357 and I responded to the traffic stop immediately and assisted. Deputy Gipson initiated the citation 1691WGN, in reference to the Failure to Maintain Lane. I observed the driver, to have glassy eyes, the odor of an alcoholic beverage and the inability to respond appropriately. I requested the white male, now known as Donald Phillips Jr., to step out of the vehicle to perform Field Sobriety Exercises. I instructed the Field Sobriety Tests and Donald Phillips Jr. advised he understood; however, was unable to complete the Field Sobriety Tests successfully. I detained the arrestee, Donald Phillips Jr. for Driving Under the Influence. Deputy Newman transported the defendant, Donald Phillips Jr. to Orient Road Jail, to Central Breath Testing and same agreed to a Breath Alcohol Test. The defendant, Donald Phillips Jr. completed the Breath Alcohol Test with the results of .170 and .172. This incident occurred within Hillsborough County, Florida. The defendant was identified via his Florida Driver License P412-199-79-132-0.
