The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above listed date and time at the above listed location, Deputy Archambeau #233046, observed a black Ford Mustang bearing Florida tag: CQSM29 racing with another vehicle. Deputy Archambeau conducted a traffic stop on the listed vehicle and made contact with the defendant. Upon making contact with the defendant, Deputy Archambeau observed multiple signs of impairment. Upon my arrival, I made contact with the defendant and also observed multiple signs of impairment. I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide two lawful breath samples to determine his breath alcohol content (BrAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of his breath. First BrAC sample (.165). Second BrAC sample (.178). The defendant received a DUI citation #AAZ6IME, which reflects the DUI charge. He was also charged with Unlawful Racing On Highway and received a Uniform Traffic Citation #AEVPSFE. The defendant was identified via his Florida Driver's License.
